

WAIVER AND HOLD HARMLESS AGREEMENT

The parents of Kendall Ayers, Elizabeth Bond, Julia Donato, Grace Geib, Melanie Green, Louisa Morgan, Margaret Martin and Jamie Woolley (the "Hosts") will hold a senior graduation party on February 26, 2017 at 7pm to celebrate the graduation of their daughters. The Hosts want the Party to be a fun and safe celebration for all and have established the following rules:

1. Alcohol, tobacco products and drugs are prohibited.
2. No Invitee may leave and then return to the Party.
3. No taunting, use of inappropriate language or other form of verbal assault, fighting or other unacceptable behavior is permitted.

Parent and Invitee each hereby agrees as follows:

Attendance at the Party is by invitation only and participation in and attendance at the Party are voluntary and subject to the rules above.

EACH OF INVITEE AND PARENT WAIVE ANY AND ALL RIGHTS THAT THEY MIGHT NOW OR IN THE FUTURE HAVE TO CLAIM OR BRING AN ACTION AGAINST THE HOSTS ON ACCOUNT OF PERSONAL INJURY OR DEATH, OR DAMAGE TO OR LOSS OF PROPERTY, ARISING OUT OF, INCIDENT TO, OR RESULTING DIRECTLY OR INDIRECTLY FROM ANY TRAVEL TO, OR ATTENDANCE OR ACTIVITIES AT, THE PARTY WHETHER SUCH INJURY, DEATH, DAMAGE OR LOSS IS CAUSED OR CONTRIBUTED TO BY THE NEGLIGENCE OF ONE OR MORE OF THE HOSTS, AND WHETHER DUE TO ANY HAZARDS PRESENT IN, ON OR AROUND THE PARTY VENUE.

EACH OF INVITEE AND PARENT FURTHER AGREE TO INDEMNIFY AND HOLD HARMLESS THE HOSTS AND THEIR RESPECTIVE PARENTS FROM ANY AND ALL ACTIONS, CAUSES OF ACTION, SUITS, LIABILITIES, CLAIMS, DEMANDS, DAMAGES, LOSSES, COSTS OR EXPENSES, INCLUDING BUT NOT LIMITED TO REASONABLE ATTORNEYS' FEES AND COSTS THAT INVITEE AND PARENT MIGHT NOW OR IN THE FUTURE HAVE AGAINST ONE OR MORE HOSTS ON ACCOUNT OF PERSONAL INJURY OR DEATH, OR DAMAGE TO OR LOSS OF PROPERTY, ARISING OUT OF, INCIDENT TO, OR RESULTING DIRECTLY OR INDIRECTLY FROM ANY TRAVEL TO, OR ATTENDANCE OR ACTIVITIES AT THE PARTY WHETHER SUCH INJURY, DEATH, DAMAGE OR LOSS IS CAUSED OR CONTRIBUTED TO BY THE NEGLIGENCE OF ONE OR MORE OF THE HOSTS AND/OR THEIR RESPECTIVE PARENTS, AND WHETHER DUE TO ANY HAZARDS PRESENT IN, ON OR AROUND THE PARTY VENUE, REGARDLESS OF WHETHER OR NOT SUCH INJURY, DEATH, DAMAGE OR LOSS IS CAUSED OR CONTRIBUTED TO BY THE NEGLIGENCE OF ONE OR MORE OF THE HOSTS AND/OR THEIR RESPECTIVE PARENTS AND WHETHER OR NOT DUE TO ANY HAZARDS PRESENT IN, ON OR AROUND THE PARTY VENUE.
